1. Property to be Consigned:

_____ will be picked up by **Riches**, out of town for \$20.00 fee plus mileage (50¢/km).

2. Effort to Sell:

***Riches** will display the consignee's property in the store and on their web site www.richesantiques.ca in attempt to sell the consignee's property.

* _____ Items consigned to **Riches** shall not be advertised elsewhere, unless there is mutual agreement made.

* _____ A reasonable price, one that the market will bear, will be mutually agreed upon between consignee and **Riches** management.

* _____ Can **Riches** use their discretion to lower prices on items if they feel it necessary?

* _____ Can **Riches** use their discretion to pass forward or dispose of any items that they know will not sell?

3. Proceeds from Sales:

Following a sale, **Riches** will retain from the transaction a commission of ...

33.3% for items decided to be **Antiques** and **40%** for items decided to be **second hand**. Consignment checks will only be issued after the 15th of each month and only if the amount comes to over one hundred dollars.

4. Ownership of Property:

You the consignee has to right to ownership of any consigned items until such time as these items are sold. When the consigned items have been with **Riches** for over a one year they then become property of **Riches**, unless previous arrangements have been made.

5. Risk of Loss:

While the consignee's items are in **Riches** possession, **Riches** will bear the risk of damage to or loss of the property. If the items are damaged or lost, **Riches** will pay you the consignee the selling price listed less the stated commission.

6. Imperfections:

For consignee's items that will not sell with out cleaning, washing, dry-cleaning, pressing, painting, gluing, rewiring or any other repairs, the cost will be deducted from the consignee's share of the sale and the rate of commission will be set at 40%.

7. Assessments:

We at **Riches** will not give appraisals. What we can do is give you an assessment of what our items would be priced at if we were selling them for you at **Riches**. We would do an in-town, in your home assessment for \$50.00 and an out of town, in your home assessment for \$50.00 plus mileage (50¢/km). For items brought into the store for assessment and left on consignment there will be no assessment costs.

8. Records:

All records of consignments items and sales are the responsibility of **Riches**.
